Please read the following terms and conditions carefully before purchasing Raffle tickets.

11. The date of the wedding which is the main Raffle prize is Sunday 17th June 2012. No alternative dates will be offered to Winners.

Venue - Bailbrook House

Wedding Dress - The Clothes Horse
